**W**HEREAS by "The Waste Lands Alienation Act, 1872," it is, amongst other things, enacted that the Governor in Council might, from time to time, by notice published in the *Gazette*, declare what parts of the waste lands are to be set apart for the sites of new towns or townships, and for suburbs thereto, and such lands should thereupon be reserved and designated as town, township, or suburban lands, as the case might be: Now, therefore, in pursuance of the provisions of the above-recited Act, the Governor in Council hereby sets apart for the site of the Township of Dublin and for suburbs thereto, the waste lands situate in the Hundred of Dublin, comprised within the boundaries, that is to say—

*Township of Dublin.*—Commencing at a point on the south-western side of the Adelaide and Port Wakefield main road, 900 links south-easterly of the east corner of Section 283, Hundred of Dublin; thence south-westerly by a line 100 links north-west of, and parallel to, the north-western boundaries of Allotments 4 and 1, for 1,427 links; thence south-easterly by a line 100 links south-west of, and parallel to the south-western boundaries of Allotments 1 and 59, for 4,756 links; thence north-easterly by a line 100 links south-east of, and parallel to the south-eastern boundaries of Allotments 59 and 80, to the south-western side of main road aforesaid; and thence in a north-westerly direction along said side of main road (along the north-eastern boundaries of Allotments 80, 27, and 4), to the point of measurement.

*Suburban Lands.*—Firstly. Commencing at the east corner of Section 283, Hundred of Dublin; thence north-north-westerly to the north-eastern corner of Section 281; thence west to the north-western corner of Section 272; thence south to the north-west corner of the Cemetery Reserve; thence east, south, and west along the north, east, and south boundaries of said reserve, and south to the south-western corner of Section 253; thence east across the road to the west corner of Section 252; thence east to the east corner of Section 244; thence north-westerly to the east corner of Section 271; and thence north-easterly to the point of commencement.

Secondly. Commencing at the east corner of Section 236, Hundred of Dublin; thence north-westerly to the north corner of Section 239; thence south-westerly to the west corner of Section 243; and thence east to the point of commencement.

*Township of Wilmington.*—Commencing at a point on the western side of the Melrose and Port Augusta Main-road, 1,430 links south-easterly of the south-eastern corner of Section 950, Hundred of Willochra; thence north-easterly at an angle of 90° from said side of road running south-

easterly for 2,700 links; thence south-easterly at right angles for 3,200 links; thence south-westerly at right angles for 4,400 links; thence 1,700 links north-westerly; thence 250 links north-easterly; thence 1,500 links north-westerly; and thence 1,450 links north-easterly to the point of commencement.

**W**HEREAS by "The Waste Lands Alienation Act, 1872," it is amongst other things enacted that the Governor in Council might, by notice in the *Gazette*, reserve and dedicate in such a manner as might seem best for the public interests, any waste lands for the interment of the dead: Now, therefore, in pursuance of the provisions of the above-recited Act, the Governor in Council hereby reserves all that piece or parcel of land commencing at the south corner of mineral section No. 1795; thence south-westerly along the north-western boundaries of mineral sections Nos. 1046 and 1796 for 2,307 links; thence north-westerly at right angles for 1,797 links to the south-eastern side of road south-east of Sections Nos. 182 and 183; thence north-easterly by said south-eastern side of road for 1014 links; thence south-westerly at an angle of 106° 3' for 332½ links; thence north-casterly at right angles for 1,307 links to the south-west boundary of mineral section 1795; and thence south-easterly along the said boundary for 1,307 links to the point of commencement (save and except a piece of land containing five acres, or thereabouts, heretofore granted for a cemetery); and dedicates the said piece of land as a site for the interment of the dead, to be called the Public Cemetery of the Corporation of the Town of Moonta.

**W**HEREAS by "The Waste Lands Alienation Act, 1872," it is, amongst other things, enacted that the Governor in Council might, by notice in the *Gazette*, reserve and dedicate in such manner as might seem best for the public interests, any waste lands as places for the recreation and amusement of the inhabitants of any city, town, or township, or for any other public purpose: Now, therefore, in pursuance of the provisions of the above recited Act, the Governor hereby reserves all that piece of land in the Hundred of Dublin, comprising all that portion of the Hundred south-east and north-east of the suburban lands north of road, north of portion of Section 128; north-west of Sections 243, 242, 241, 240, and 239; and south-west of the Adelaide and Port Wakefield main road, exclusive of the Township of Dublin; and dedicates the said piece of land as a place for the recreation and amusement of the inhabitants of the Township of Dublin, to be called Park Lands.
